Directions: From 880, take Jackson Street East. Go 2 miles. Turn right at Mission Blvd. Go .7 miles. Turn left at Carlos Bee Blvd. Go uphill, stay to the far right to enter the campus. At stop sign, turn left onto Loop Rd. At next stop sign at rear of campus, turn right, and right again into Parking Lot K. **Parking fee \$5 for daily permit**

CGC Test: 8:30 a.m. Max: 15 entries. Evaluator: **Penny Robinson**. Must bring a dog brush. Buckle collars required. (No training collars or haltis)

CONFORMATION: 9 a.m. Jr. Showmanship; 9:30 a.m. Mixed Breeds; 10 a.m. all other Breed Competition

Classes divided by sex. Puppies: 4-6 mo., 6-9 mo., 9-12 mo., Adults: Novice, Open. Puppies will not compete with adults. All puppy judging will be completed prior to adult judging within a breed. Each group will be judged following all breeds of that group. Ear racks acceptable. Professional handlers may show ONLY their own dogs or those owned by members of their immediate family. Only AKC approved collars and leads will be allowed. Jr. Showmanship: Ages 6-9, 10-13, 14-17. **Mixed Breed Conformation** is open only to MBDCa-registered dogs. Specify Class I, II, III or BOB on entry form. **Judge - TBA**

OBEDIENCE & RALLY: 9 a.m.

Exhibitors are responsible for being at ringside for judging in numerical order. Food allowed. Please pick up any food you or your dog drops.

The judge is in charge of the ring and will allow reasonable corrections and the repeat of an exercise or two.
